WHEREAS, the agency benefited from the collection of premiums and closing fees resulting from transactions examined by the examiner during the time the license had expired; and

WHEREAS, William S. Wetterer III, owner, is authorized to act on behalf of the agency and obligate it to perform in accordance with this agreement; and

WHEREAS, the employee, William S. Wetterer III, has obtained the proper license and is currently practicing the business of selling, soliciting or negotiating title insurance in the State of Indiana and the other employee, Linda Herp, remains unlicensed.; and

WHEREAS, the parties desire to resolve their differences and settle the issues without a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and the Respondent in this administrative action.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives its right to a public hearing on the issues in this action.
- 4. Respondent waives its right for a judicial review of this matter.
- 5. Respondent agrees to pay a civil penalty of \$750.00 within thirty days (30) of the signing of the Commissioner's Final Order for non-compliance with the Indiana insurance producer licensing statutes.
- 6. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
