WHEREAS, Respondent has been a licensed Resident Producer since May, 2003; and WHEREAS, on August 21, 2013 Respondent was convicted of Possession of Cocaine Or A Narcotic Drug, a Class D Felony, and Possession of Cocaine Or A Narcotic Drug Weighing Over Three Grams, a class C Felony; and

WHEREAS, Respondent's conduct, as alleged herein, constitutes two separate and distinct violations of Indiana Code §27-1-15.6-12(b)(6); and

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
- 5. Respondent's Resident Producer's license number 437504 shall be suspended for sixty (60) days beginning the day of the Commissioner's Final Order adopting this Agreed Entry.
- 6. Provided no other issues arise, once said suspension is completed, Respondent's license will be placed on probation for a period of twenty four (24) months.
- 7. Respondent understands that this Agreed Entry will result in a state action against her Indiana resident license, and Respondent may be required to report that action to other states where she holds or applies for professional licenses.
- 8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
