WHEREAS, Respondent, a resident insurance producer, has held license number 2742300 since June 16, 1997 ("Respondent's license"); and

WHEREAS, on or about October 7, 2013, Respondent was terminated for cause from American Family Life Assurance Company of Columbus (AFLAC) conducted an internal fraud investigation; and

WHEREAS, AFLAC's investigation revealed that Respondent placed ineligible people on a group policy; and

WHEREAS, the Department alleges that the behavior described herein is in violation of Indiana Code § 27-1-15.6-12(b)(8); and

WHEREAS, the Department alleges that the behavior described herein is also in violation of Indiana Code § 27-1-15.6-12(b)(5); and

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to settle these issues without a hearing.

IT IS, THEREFORE, NOW AGREED by and between the Parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and of the Respondent to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives her right to a public hearing on this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
- 5. Respondent agrees to the accept the permanent revocation of her Insurance Producer's License.
- 6. Respondent is aware that failure to comply with any term of this Agreed Entry will result in this matter being set for hearing.
- 7. Respondent understands that this Agreed Entry will result in a state action against her license and Respondent may be required to report this action to other states where she holds or applies for professional licenses.

- 7. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 8. Respondent has carefully read and examined this agreement and fully understands and accepts its terms.
