- 6. Applicant's license application will be granted once said administrative fine is paid, provided that no other issues arise.
- 7. Respondent has carefully read this agreement and fully understands and accepts its terms.
- 8. Respondent is aware that failure to comply with these terms may result in this matter being set for hearing or additional penalties.
- 9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that the presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
