FINAL ORDER

1. Respondent shall pay an administrative fine of Two Hundred Fifty Dollars and no/100 (\$250.00) within thirty (30) days of today’s date.

2. Respondent's license shall be granted once said administration fine is paid, provided that no other issues arise.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance (the "Department"), by counsel, Michael F. Mullen, and Applicant, Peter Lucas ("Applicant"). This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, Applicant submitted a Non-Resident Producer License application on November 6, 2013; and,

WHEREAS, Applicant failed to disclose on his license application that the State of Wisconsin denied his license application on July 5, 2013; and,

WHEREAS, the Department alleges Applicant's conduct constitutes a violation of Ind. Code § 27-1-15.6-12(b)(1).

IT IS THEREFORE NOW AGREED by and between the Department and Respondent (collectively, the "Parties") as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives the right to a public hearing.
4. Respondent voluntarily and freely waives the right to judicial review of this matter.
5. Respondent shall pay an administrative fine in the amount of Two Hundred Fifty Dollars and no/100 (\$250.00) within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
6. Applicant's license application will be granted once said administrative fine is paid, provided that no other issues arise.
7. Respondent has carefully read this agreement and fully understands and accepts its terms.
8. Respondent is aware that failure to comply with these terms may result in this matter being set for hearing or additional penalties.
9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that the presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.


