## AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Michael F. Mullen, and Shane Carney ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, On July 20111, Respondent submitted an application for a Resident Producer's license; and,

WHEREAS, on said license application, Respondent failed to disclose a January 2011 Felony charge of Operating a Vehicle While Intoxicated Enhancement; and,

WHEREAS, the Department alleges that Respondent's conduct constitutes a violation of Indiana Code §27-1-15.6-12(b)(1); and,

WHEREAS, on August 30, 2011, Respondent was issued license number 772993 ("Respondent's license"); and,

WHEREAS, Respondent's license expired on November 30, 2013; and,

WHERAS, while licensed, Respondent failed to timely inform the Commissioner that on December 1, 2011 he pled guilty to the previously noted felony charge; and,

WHEREAS, the Department further alleges that Respondent's conduct constitutes a violation of Indiana Code §27-1-15.6-12(b)(6); and,

WHEREAS, Respondent now seeks to reinstate his license; and,

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

## IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
- 5. Respondent acknowledges Ind. Code § 27-1-15.6-17(b) requires him to report to the Commissioner, not more than thirty (30) days after an initial pretrial hearing date, any criminal prosecution initiated in any jurisdiction.
- 6. Respondent shall pay an administrative fine in the amount of Two Hundred Fifty Dollars and 00/100 (\$250.00) within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
- 7. Respondent's license will be placed on probation for a period of twelve (12) months.

- 8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 9. Respondent has carefully read this agreement and fully understands and accepts its terms.
