MOTION TO SUSPEND LICENSE

Comes now the Enforcement Division of the Indiana Department of Insurance (the "Department"), by counsel, Michael F. Mullen, and respectfully requests that John W. Pribil's nonresident insurance license be suspended, and in support thereof states:

- Respondent John W. Pribil ("Respondent") has held insurance producer license number 673525 since October 27, 2009 ("Respondent's license").
- 2. On June 28, 2013, the Department was informed that Golden Rule terminated Respondent for cause.
- On April 30, 2014, the Department mailed Respondent a letter requesting he provide a list of all appointments held during the preceding year via certified mail number 9214 8901 0661 5400 0032 2071 14.
- Respondent received this request on May 5, 2014 (Attached hereto as "Exhibit A").
- 5. Pursuant to Indiana Code § 27-1-15.6-12(g), a producer shall, **not more than ten (10)**days after receiving a request in a certified letter, furnish the Commissioner with a full and complete report listing each insurer with which he has held an appointment during

the year preceding the request. (Emphasis added).

6. Therefore, per Ind. Code § 27-1-15.6-12(g), Respondent was to furnish an appointment

report no later than May 15, 2014.

7. To date, Respondent has failed to provide an appointment report, or otherwise contact the

Department.

8. Pursuant to Indiana Code § 27-1-15.6-12(h), if a licensee fails to provide the requested

report not more than ten (10) days after he receives the request, the Commissioner may,

without a hearing, suspend any insurance license held by the licensee pending receipt of

the appointment report (emphasis added).

9. Respondent failed to provide an appointment report and said report is now past due; his

conduct warrants disciplinary action.

WHEREFORE, the Enforcement Division of the Indiana Department of Insurance, by

counsel, Michael F. Mullen, requests that Respondent's insurance license number 673525 be

suspended, until Respondent furnishes an appointment report.
