ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance, pursuant to the Indiana Administrative Act, Indiana Code 4-21.5-1 et seq. and Indiana Code § 27-1-15.6-12, hereby gives notice to Kevin J. James ("Respondent") of the following Administrative Order:

- 1. Respondent is a resident insurance producer with the State of Indiana, holding license number 1439710.
 - 2. Respondent's license will expire on May 31, 2014.
- 3. Respondent's license is currently suspended by Commissioner's Order under cause number 11574-AG12-1031-111.
- 4. In addition to suspending his license, the Commissioner's Order directed Respondent to pay a Seven Hundred Fifty Dollars and no/100 (\$750.00) within ninety (90) days of September 6, 2013 and complete six (6) hours of ethics training within two (2) years.

- 5. To date, Respondent has not paid the fine required by Order of the Commissioner. Respondent is well past the ninety (90) dead line to do so.
- 6. On April 15, 2014, a criminal complaint was filed in the United States District Court for the Southern District of Indiana whereby Respondent was charged with Securities Fraud, Mail Fraud, and Money Laundering under case number 1:14-mj-00191-DKL.
- 7. Upon information and belief, Respondent is currently detained in the Marion County Jail as ordered by the April 21, 2014 Order of Detention under the above-mentioned criminal cause number.
- 8. Indiana Code § 27-1-15.6-12(b) permits the Commissioner to refuse to issue or renew an insurance producer license for a number of causes.
- 9. Pursuant to Indiana Code § 27-1-15.6-12(b)(1), violating an order of the Commissioner is such a cause.
- 10. The Commissioner is permitted to refuse to renew Respondent's license because he has violated the Commissioner's previous order requiring payment of a fine.
- 11. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.
- 12. The Commissioner further notifies Respondent that, pursuant to Indiana Code §27-1-15.6-12(d), Respondent may, within sixty (60) days of receiving this Notice, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies

Respondent that Respondent's license shall not be renewed.
