

**AGREED ENTRY**

This Agreed Entry is executed by Robert Hummel, attorney for and on behalf of the Indiana Department of Insurance ("Department"), and Mattingly and Hanson Title Solutions, Inc. dba Hastings and Allen Land Title Agency, ("Respondent"), a title insurance agency licensed to do business in Indiana, to resolve all issues in the above captioned matter. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance ("Commissioner").

WHEREAS, Respondent is a resident title insurance agency holding license number 580022; and

WHEREAS, the Department alleges that Respondent has paid an unlicensed person for selling, soliciting, or negotiating insurance in Indiana in which is a violation of Indiana Code §27-1-15.6-13(a & b);


WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives its right to a public hearing in this matter.
4. Respondent voluntarily and freely waives its right to judicial review of this matter.
5. Respondent agrees to pay an administrative penalty in the amount of one thousand one hundred and nine dollars (\$1,109.00) to the Department. The payment is due in full within thirty (30) days after the filing of the Commissioner's Final Order.
6. Respondent shall develop, provide and implement policies to ensure all licensed employees and any agency that requires an insurance license are in compliance with Indiana insurance law.
7. The Department agrees to accept Respondent's compliance with this agreement as full satisfaction of this matter.

8. Respondent has carefully read and examined this agreement and fully understands its terms.
9. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.
10. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
11. Respondent is aware that failure to comply with any term of this agreement will result in the matter being set for hearing and may result in permanent revocation of its license and/or an additional civil penalty.
