FINAL ORDER



Mullen, and Price Wise Insurance Services, LLC ("Respondent"), an Indiana Nonresident Producer Organization, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance (the "Commissioner") for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent shall pay an administrative fine of Two Hundred Fifty Dollars and no/100 (\$250.00) within thirty (30) days of today's date.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Michael F. Mullen, and Price Wise Insurance Services, LLC ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, Respondent has held license number 925663 since December 16, 2013; and,

WHEREAS, in December 2013, Respondent submitted an application for said Non-Resident Producer Organization's license; and,

WHEREAS, on said application, Respondent denied any owner, partner, officer, or director having ever been convicted of a crime; and,

WHEREAS, Respondent an owner, partner, officer, or director has been convicted of a crime. Specifically, in June 2006, Robert E. Langner pled guilty to a misdemeanor of Possession of Marijuana; and,

WHEREAS, the Department alleges that Respondent's conduct constitutes a violation of Indiana Code § 27-1-15.6-12(b)(1); and,


WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of completing formal hearing procedures.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives the right to a public hearing on this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Respondent acknowledges Ind. Code § 27-1-15.6-17(b) requires it to report to the Commissioner, not more than thirty (30) days after an initial pretrial hearing date, any criminal prosecution initiated in any jurisdiction.
6. Respondent also acknowledges Ind. Code § 27-1-15.6-17(a) requires it to report to the Commissioner, not more than thirty (30) days after the final disposition of the matter, any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana.


7. Respondent shall pay an administrative fine in the amount of Two Hundred Fifty Dollars and 00/100 (\$250.00) within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
9. Respondent has carefully read this agreement and fully understands and accepts its terms.


