**FINAL ORDER**

The Indiana Department of Insurance ("Department"), by counsel, Michael F. Mullen, and Shawn Davidson ("Applicant"), an applicant for Indiana Producer license, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance (the "Commissioner") for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. For his failure to disclose two (2) separate misdemeanor convictions from 1999 and 2000, Applicant shall pay an administrative fine of Five Hundred Dollars and no/100 (\$500.00) within thirty (30) days of today's date.
2. Upon payment of said administrative fine, Applicant's license shall be granted.

**AGREED ENTRY**

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Michael F. Mullen, and Shawn Davidson ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, In February 2014, Respondent submitted an application for a Resident Producer's license; and,

WHEREAS, On that application, Respondent indicated that he had not been convicted of any crimes, when, in fact, he had been convicted of two (2) criminal offenses; and,

WHEREAS, On November 03, 1999, Respondent pled guilty to a Class B Misdemeanor conviction: Public Intoxication; and,

WHEREAS, On June 19, 2000, Respondent pled guilty to a Class B Misdemeanor conviction: Public Intoxication; and,

WHEREAS, Respondent failed to disclose both these criminal applications on his application for licensure; and,

WHEREAS, the Department alleges that Respondent's conduct constitutes a violation of Indiana Code §27-1-15.6-12(b)(1); and,

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.


IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives the right to a public hearing on this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Respondent acknowledges Ind. Code § 27-1-15.6-17(b) requires him to report to the Commissioner, not more than thirty (30) days after an initial pretrial hearing date, any criminal prosecution initiated in any jurisdiction.
6. Respondent shall pay an administrative fine in the amount of Five Hundred Dollars and 00/100 (\$500.00) within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
7. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall

not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

8. Respondent has carefully read this agreement and fully understands and accepts its terms.
