FINAL ORDER AND APPROVAL



The Department alleges Respondent forged the names of six (6) consumers to documents related to an insurance transaction.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED, by the Commissioner of Insurance:

1. Respondent’s Indiana resident producer’s license, number 425785, is permanently revoked, effectively thirty (30) days from today’s date.

AGREED ENTRY

This Agreed Entry is entered into by and between the Enforcement Division of the Indiana Department of Insurance (the "Department"), by and through counsel, Michael F. Mullen, and Respondent Jennifer Lynn Shiflet ("Respondent") to resolve all matters under Cause Number 10849-AG12-0417-026. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance (the "Commissioner").

WHEREAS, on September 4, 2002, Respondent was issued resident producer license number 425785 ("Respondent's Indiana license"); and,

WHEREAS, Respondent's Indiana license is active; and,

WHEREAS, the Department alleges, between January 1, 2013 and July 30, 2013, Respondent forged the signatures of six (6) consumers for the purpose of transferring the consumers' business from Respondent's previous employer to her agency; and,

WHEREAS, the Department alleges each forgery is a separate violation of Indiana Code § 27-1-15.6-12(b)(10); and,

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve their differences and settle all issues without the necessity a hearing.

IT IS, THEREFORE, NOW AGREED by and between the Parties as follows:

1. The Commissioner has jurisdiction over the subject matter and Parties in this administrative action.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives her right to a public hearing on this matter.
4. Respondent's Indiana license shall be permanently revoked, effective thirty (30) days from the date the Commissioner adopts this Agreed Entry via Final Order.
5. The Department agrees to accept Respondent's compliance with the terms of this Agreed Entry as full resolution of this matter.
6. Respondent has carefully read and examined this Agreed Entry and fully understands its terms.
7. Respondent has entered into this Agreed Entry freely on her own volition and has not been subject to duress, threat, undue influence, or any form of coercion.
8. Respondent is aware that failure to comply with any term of this Agreed Entry may result in this matter being set for hearing.
9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that the presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

10. Respondent has carefully read this agreement and fully understands and accepts its terms.
