FINAL ORDER

The Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Michael F. Mullen, and Ronald I. Kulick ("Respondent"), an Indiana Nonresident Producer, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance (the "Commissioner") for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent shall pay a civil penalty of Five Hundred Dollars and no/100 (\$500.00) within thirty (30) days of today's date, for failing to disclose a child support arrearage on his applications.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Michael F. Mullen, and Ronald I. Kulick ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, on September 15, 2011 and February 21, 2014, Respondent submitted an application for a Nonresident Producer's license and Nonresident Independent Adjuster's license, respectively; and,

WHEREAS, on said license applications, Respondent failed to disclose he is not compliant with a court order imposing a child support obligation; and,

WHEREAS, the Department alleges that Respondent's failure to disclose his outstanding child support obligation is a violation of Indiana Code § 27-1-15.6-12(b)(1); and,

WHEREAS, the Department further alleges that Respondent's failure to comply with a child support obligation is a violation of Indiana Code §27-1-15.6-12(b)(13); and,


WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this _____ Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives the right to a public hearing on this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Respondent acknowledges Ind. Code § 27-1-15.6-17(b) requires him to report to the Commissioner, not more than thirty (30) days after an initial pretrial hearing date, any criminal prosecution initiated in any jurisdiction.
6. Respondent also acknowledges Ind. Code § 27-1-15.6-17(a) requires him to report to the Commissioner, not more than thirty (30) days after the final disposition of the matter; any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana.
7. Respondent shall pay an administrative fine in the amount of Five Hundred Dollars and 00/100 (\$500.00) within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.


8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
9. Respondent has carefully read this agreement and fully understands and accepts its terms.

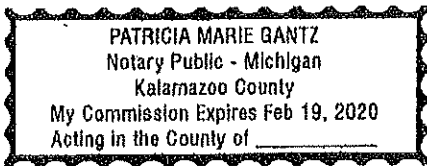
