PRELIMINARY ADMINISTRATIVE ORDER AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Ind. Code § 4-21.5-1 et seq., and Ind. Code § 27-1-15.6-12, hereby gives notice to **Michael Toussau** ("Applicant") of the following Administrative Order:

- 1. Applicant filed an application for licensure with the Department on or around April 14, 2014. Following a review of materials submitted by Applicant in support of his application, the Commissioner of the Department ("Commissioner"), being fully advised, now hereby notifies Applicant that he has not fully met the requirements of licensure as stated by Ind. Code § 27-1-15.6-12(b); specifically, Applicant was convicted of a Class D felony in November 2004 for fleeing and eluding a peace officer.
 - 2. Ind. Code § 27-1-15.6-12(b) provides, in part, as follows:

The commissioner may reprimand, levy a civil penalty, place an insurance producer on probation, suspend an insurance producer's license, revoke an insurance producer's license for a period of years, permanently revoke an insurance producer's license, or refuse to issue or renew an insurance producer license, or take any combination of these actions, for any of the following causes:

- (6) Having been convicted of a felony.
- 3. Applicant may, not more than sixty-three (63) days after this notice is mailed, make a written demand to the Commissioner for a hearing to determine the reasonableness of the Commissioner's action. The hearing will be held not more than thirty (30) days after Applicant's demand and will be conducted under Ind. Code 4-21.

IT IS THEREFORE ORDERED that Applicant's request for licensure is hereby denied pursuant to Indiana Code § 27-1-15.6-12(b).
