**FINAL ORDER**


The Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Holly A. Williams, and Kara Fields ("Applicant"), an applicant for a resident producer license, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance (the "Commissioner") for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Applicant shall pay a civil penalty in the amount of Two Hundred Fifty Dollars and 00/100 (\$250.00) within thirty (30) days of today's date.
2. Provided Applicant complies with paragraph 1 above, Applicant shall be granted a resident producer license.

**AGREED ENTRY**

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Holly A. Williams, and Kara Fields ("Applicant"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, on August 4, 2014, Applicant submitted an application for a Resident Producer's license; and,

WHEREAS, on said application, Applicant failed to disclosed a 2009 administrative action taken in the State of Ohio and,

WHEREAS, the Department alleges that Applicant's conduct constitutes a violation of Indiana Code §27-1-15.6-12(b)(1); and,

WHEREAS, the Department and Applicant (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Applicant voluntarily and freely waives the right to a public hearing on this matter.
4. Applicant voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Applicant acknowledges that Indiana Code § 27-1-15.6-17(a) requires her to report to the Commissioner any administrative action taken against her, not more than thirty (30) days after the final disposition of the matter.
6. Applicant further acknowledges that Indiana Code § 27-1-15.6-17(b) requires her to report to the Commissioner any criminal prosecution, not more than thirty (30) days after an initial pretrial hearing date.
7. Applicant shall pay a civil penalty in the amount of Two Hundred and Fifty Dollars and 00/100 (\$250.00) within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
8. Should no other issues arise and Applicant complies with the civil penalty requirement as stated in paragraph seven (7) above, Applicant shall be granted a resident producer license.
7. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

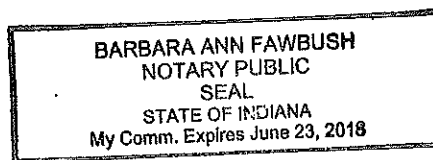
