This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Holly Williams, and David K. Hartung (“Respondent”), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of the Department’s Commissioner, Stephen W. Robertson.

WHEREAS, Respondent is a licensed Resident Insurance Producer, holding license number 2232710; and

WHEREAS, on or about November 29, 2013, Respondent was terminated from United Insurance Company (“UIC”) due to field shortages; and

WHEREAS, UIC conducted an audit and discovered deficiencies in the amount of \$4914.23; and

WHEREAS, Respondent's actions, as alleged herein, are in violation of Indiana Code § 27-1-15.6-12(b)(8); and


WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Respondent for this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives his right to a public hearing on this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Respondent agrees to the Permanent Revocation of his Resident Insurance Producer's License.
6. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

7. Respondent has carefully read and examined this agreement and fully understands and accepts its terms.
