AGREED ENTRY

WHEREAS, the Division alleges that Respondent has paid an unlicensed person for selling, soliciting, or negotiating insurance in Indiana in violation of Indiana Code §27-1-15.6-13(a & b); and

WHEREAS, James E. Schaefer is authorized to act on behalf of Respondent and obligate it to perform in accordance with this agreement; and

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and Respondent in this civil action.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives its right to a public hearing in this matter.
- 4. Respondent voluntarily and freely waives its right to judicial review of this matter.
- 5. Respondent shall not engage in the sale, solicitation, or negotiation of title insurance while unlicensed.
- 6. Respondent shall obtain an Indiana title insurance producer license within (30) days after the Commissioner signs the Final Order.
- 7. Respondent agrees to pay a civil penalty in the amount of four thousand three hundred dollars (\$4,300.00) to the Department. The payment is due in full within thirty (30) days after the Commissioner signs the Final Order.
- 8. The Department agrees to accept Respondent's compliance with this agreement as full satisfaction of this matter.

- 9. Respondent has carefully read and examined this agreement and fully understands its terms.
- 10. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 11. Respondent is aware that failure to comply with any term of this agreement will result in the matter being set for hearing and may result in permanent revocation of its license and/or an additional civil penalty.
