AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Joshua D. Harrison, and Paul J. Tanner ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, on July 12, 2013, Respondent submitted an application for a Nonresident Producer's license and was granted license number 889586; and,

WHEREAS, in said application, Respondent failed to disclose that he had been charged in California with felony First Degree Residential Burglary and Felony Grand Theft of Personal Property; and,

WHEREAS, on July 11, 2014, Respondent disclosed that he had reached an agreement with the prosecutor to plea to misdemeanor trespassing in lieu of the aforementioned and previously unreported felony charges; and,

WHEREAS, the Department alleges that Respondent's failure to disclose his December 3, 2012 pending felony charges is a violation of Indiana Code § 27-1-15.6-12(b)(1); and,

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and the Parties to this

 Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
- 5. Respondent acknowledges Ind. Code § 27-1-15.6-17(b) requires him to report to the Commissioner, not more than thirty (30) days after an initial pretrial hearing date, any criminal prosecution initiated in any jurisdiction.
- 6. Respondent shall pay an administrative fine in the amount of Two Hundred Fifty Dollars and 00/100 (\$250.00) within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
- 7. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
