AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Holly Williams, and Bryan P. Luttman ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, on September 22, 2008, Respondent submitted an application for a Resident Producer's license and was granted license number 617067; and,

WHEREAS, on August 19, 2014 Respondent applied to add a Life, Accident and Health qualification; and,

WHEREAS, on said application Respondent disclosed a 1995 misdemeanor conviction of Battery not previously disclosed; and,

WHEREAS, the Department alleges that Respondent's failure to disclose his conviction is a violation of Indiana Code § 27-1-15.6-12(b)(1); and,

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
- 5. Respondent acknowledges Ind. Code § 27-1-15.6-17(b) requires him to report to the Commissioner, not more than thirty (30) days after an initial pretrial hearing date, any criminal prosecution initiated in any jurisdiction.
- 6. Respondent also acknowledges Ind. Code § 27-1-15.6-17(a) requires him to report to the Commissioner, not more than thirty (30) days after the final disposition of the matter, any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana.
- 7. Respondent shall pay an administrative fine in the amount of Two Hundred Fifty Dollars and 00/100 (\$250.00) within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
- 9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall

not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

10. Respondent has carefully read this agreement and fully understands and accepts its terms.
