**FINAL ORDER**


The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Joshua Harrison, and Jared Duff (“Respondent”), an Indiana Resident Producer, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance (the “Commissioner”) for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Applicant's license shall be placed on probationary status for a period of (1) year, and Respondent shall be ordered to pay an administrative fine in the amount of Five Hundred Dollars and 00/100 (\$500.00). The administrative fine shall be stayed during probationary period. If no further violations arise during said probationary period, the fine amount shall be vacated. Should additional violations manifest, this fine shall be in addition to any administrative actions for the new violation.

**AGREED ENTRY**

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Joshua Harrison, and Jared Duff (“Applicant”), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, on or around April 23, 2014, Applicant submitted an application for a Resident Producer’s license and was granted license number 948913; and,

WHEREAS, on or around September 16, 2014, Applicant submitted an application to add additional qualifications for Life, Accident and Health; and,

WHEREAS, on the September 16, 2014 application, Applicant disclosed two misdemeanors occurring in 2000, which were not disclosed on Applicant’s previous license application submitted on April 23, 2014; and,

WHEREAS, the Department alleges that Applicant's conduct constitutes violations of Indiana Code §27-1-15.6-12(b)(1), which state, the producers are prohibited from providing incorrect, misleading, incomplete, or materially untrue information in a license application; and,

WHEREAS, the Department and Applicant (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.


IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Applicant voluntarily and freely waives the right to a public hearing on this matter.
4. Applicant voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Applicant's license shall be placed on probationary status for a period of (1) year, and Respondent shall be ordered to pay an administrative fine in the amount of Five Hundred Dollars and 00/100 (\$500.00).
6. The administrative fine shall be stayed during probationary period. If no further violations arise during said probationary period, the fine amount shall be vacated.
7. Should additional violations manifest, this fine shall be in addition to any administrative actions for the new violation.
8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall


not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

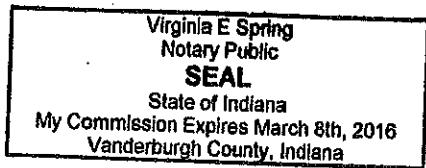
