FINDINGS OF FACT AND CANCELLATION OF LICENSE ORDER

WHEREAS, on September 12, 2014, the Indiana Department of Insurance Bail Bond Division (“Division”) received notification from Universal Fire and Casualty Insurance Company that the appointment of Kaci Wasson (“Respondent”) to represent the company as a bail agent was terminated, effective September 12, 2014. *See Exhibit “A” attached hereto.*

WHEREAS, on September 12, 2014, the Division sent a letter to Respondent at her home address of record informing her that, pursuant to Ind. Code §27-10-3-13, if she was not appointed with another surety company within thirty (30) days, she must surrender her license to the Commissioner for cancellation. *See Exhibit “B” attached hereto.*

WHEREAS, to date Respondent has failed to respond to the September 12, 2014 letter, has failed to surrender her license, and more than thirty (30) days have passed since the termination of her appointment.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's bail agent license, number 5465, is hereby cancelled, effective immediately.

FURTHERMORE, Respondent may make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.


