WHEREAS, Respondent has failed to file the Surplus Lines Semi-Annual Tax Reports for the periods ending June 30, 2012 and December 31, 2012 as well as provide a list of appointments within ten (10) days as requested by the Commissioner.

WHEREAS, Respondent's failure to file said tax report violates IC 27-1-15.8-4(a) and failure to provide said list constitutes a violation of IC 27-1-15.6-12(g).

WHEREAS, the Commissioner has the authority to issue an order suspending Respondent's license without a hearing pending receipt of said list of appointments pursuant to IC 27-1-15.6-12(g).

WHEREAS, the Commissioner shall set this matter for hearing upon request of Respondent pursuant to IC 4-21.5-4-4.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 516699 and 516539 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the tax reports, the list of appointments and response requested by the Commissioner.
