Respondent shall implement these policies and provide the Department a copy of these policies within thirty (30) days after the signing of this Final Order.

WHEREAS, Respondent is a non-resident title insurance agency licensed in the State of Indiana, holding license number 35408;

WHEREAS, Indiana Code § 27-1-15.6-13 (a) & (b) requires Respondent to only pay a commission, service fee, brokerage fee, or other valuable consideration to a person for selling, soliciting, or negotiating insurance in Indiana if that person is licensed;

WHEREAS, Respondent has paid a person for selling, soliciting, or negotiating insurance in Indiana while said person was not licensed;

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve their differences and settle the issues without the necessity of a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on the issues in this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent shall pay an administrative fine of twenty three thousand dollars (\$23,000.00) to the Department within thirty (30) days after the Commissioner's Final Order adopting this Agreed Entry.
- 6. Respondent shall develop, provide, and implement policies to ensure all employees and any agency that requires an insurance license is in compliance with Indiana insurance law. Respondent shall implement these policies and provide the Department a copy of these policies within thirty (30) days of the Commissioners Final Order.
- 7. The Department agrees to accept Respondent's compliance with this agreement as full satisfaction of this matter.
- Respondent has carefully read and examined this agreement and fully understands its terms.

- Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.
- 10. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 11. Respondent is aware that failure to comply with any of the terms of this agreement will result in the matter being set for a hearing.
