## FINDINGS OF FACT, CONCLUSIONS OF LAW, AND RECOMMENDED ORDER

Administrative Law Judge, Amy L. Beard, ("ALJ"), having considered and reviewed all of the evidence, now renders a decision in the matter of the Insurance Producer License Application of Derek Holm under Cause Number 13138-AD14-0630-024. This matter came to be heard by the ALJ at the Indiana Department of Insurance, 311 West Washington Street, Indianapolis, Indiana, at 1:00 p.m. EST on August 20, 2014.

The Indiana Department of Insurance ("Department") was represented at the administrative hearing by counsel. The Petitioner, Astrid Recinos, ("Applicant") appeared in person and without legal counsel. At the administrative hearing, witnesses testified under oath, evidence was heard, and exhibits were received into evidence.

Based upon the evidence presented at the hearing, the ALJ now makes the following Findings of Fact, Conclusions of Law, and Recommended Order pursuant to Indiana Code section 4-21.5-3-27.

## FINDINGS OF FACT

- 1. Astrid Recinos ("Applicant") was properly notified of the above referenced hearing date and time by U.S. Certified Mail #9214 8901 0661 5400 0036 5950 33.
- 2. The Department received Applicant's property and casualty insurance producer license application on June 23, 2014. *Exhibit A*.
- 3. Applicant's license application was denied on July 11, 2014, by order of the Commissioner due to Applicant having been found guilty of a felony. *Preliminary Administrative Order and Notice of License Denial*.
- 4. On July 20, 2014, Applicant made a request for a hearing to reconsider the initial denial of her producer license application and a hearing date was set for August 20, 2014. *Exhibit C; Notice of Hearing.*
- 5. On or about October 29, 2004, Applicant was charged with two counts of Sexual Misconduct With a Minor. *Exhibit D*.
- 6. The Affidavit of Probable Cause stated Applicant was an employee of Cary Home, and was involved in inappropriate conduct with a resident. Applicant confirmed the allegations and reported that Applicant had kissed the resident. *Exhibit E*.
  - 7. Cary Home is a boy's school or detention center. *Transcript pg. 25*.
- 8. Applicant was twenty-two (22) years old at the time of the incident and the resident was fifteen (15) years old. *Transcript pg. 8*.
- 9. Applicant was terminated from Cary Home on August 30, 2004. *Transcript pg.* 38.

- 10. On August 12, 2005, Applicant was sentenced to one and one half (1 ½) years on each of the two counts, to run concurrently with six (6) months executed on Community Corrections and one year suspended on supervised probation. *Exhibit D*.
- 11. Applicant successfully completed six (6) months of house arrest, one (1) year of probation, and completed all necessary psychological evaluations. *Exhibit B*.
- 12. On or about October 15, 2008, Applicant's felony convictions were reduced to A Misdemeanors. *Exhibit B, D.*
- 13. Applicant submitted several letters of recommendation. These letters included recommendations from Jason Dickelmann, a State Farm Agent/Owner and Applicant's current employer; Janet English, the Office Manager for Applicant's current employer; Judy L. Edwards, the Director of Religious Education at the church where Applicant volunteers; and Gwen Adams, the Advocate/Officer Manager for the confirmation class with which Applicant assists. *Exhibit* 2, 3, 4, 5.
- 14. Jason Dickelmann, Janet English, Judy Edwards, and Gwen Adams are all aware of Applicant's criminal conviction. *Transcript pgs. 20-21, 24*.
- 15. Applicant received a Bachelor of Arts Degree from Purdue University, an Associate of Science in Liberal Arts Degree from Ivy Tech Community College, and a Phlebotomy Technician certification. *Exhibit 6*.
- 16. Applicant worked at Macy's as a sales associate from November 2001 through May 2014. *Exhibit 1*.
- 17. Applicant began working at Jason Dickelmann's State Farm agency as a service representative in June 2014. *Exhibit 1*.

16. Applicant stated that a career in the insurance industry will provide her with the opportunity to help people. *Transcript pg. 19*.

#### **CONCLUSIONS OF LAW**

- 1. The Commissioner of Insurance has jurisdiction over both the subject matter and the parties to this action.
- 2. This hearing was held in compliance with the Administrative Orders and Procedures Act of the Indiana Code and all procedures and rules set forth by such Act have been followed in this matter.
- 3. Service of process was completed via the use of the United States Mail in compliance with the statute and due process requirements.
  - 4. Applicant received a felony conviction for Sexual Misconduct With a Minor.
- 5. Ind. Code §27-1-15.6-12(b)(6) states that the Commissioner may refuse to issue an insurance producer license if the applicant has been convicted of a felony.
- 6. Applicant's felony convictions were reduced to A Misdemeanors in 2008; however, the facts surrounding Applicant's conviction are indicative of dishonest, untrustworthiness, and incompetence as required by Ind. Code §27-1-15.6-12(b)(8).
- 7. Applicant has not met her burden of proof to show that the Commissioner's decision to deny the insurance producer license application should be reversed.
- 8. Findings of Fact that can be adopted as a Conclusion of Law are hereby incorporated herein as such.

## RECOMMENDED ORDER

With the Findings of Fact and the Conclusions of Law as stated, the Administrative Law Judge now recommends to the Commissioner of Insurance the following:

- 1. The Preliminary Administrative Order and Notice of License Denial of July 11, 2014, should be AFFIRMED.
- 2. The Applicant's request for an insurance producer license shall be DENIED. denying Applicant's insurance producer license application.
