

1. Respondent’s Indiana Resident Insurance Producer License, number 937017, is hereby permanently revoked.

2. The Department agrees to accept this agreement as full resolution of this matter.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Joshua Harrison, and Giovanni Jean-Baptiste ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, in February 2014, Respondent applied for and received a non-resident producer license; and,

WHEREAS, on said application, Respondent disclosed three (3) convictions: 1 count of Forgery 3rd degree on 09/22/2009, 1 count of Possessing a device to defraud administration of drug test on 01/11/2010, 1 count of Violation of Probation on 03/09/2012; and,

WHEREAS, Indiana Code 27-1-15.6-17 requires that a producer shall report to the commissioner any administrative action taken by another jurisdiction within thirty (30) days; and,

WHEREAS, on March 11, 2014 Respondent was denied a license in the state of Wisconsin for criminal record; and,

WHEREAS, Respondent failed to notify the Indiana Department of Insurance of this license denial within thirty (30) days; and,

WHEREAS, on September 5, 2014 Respondent's license was revoked in the state of Virginia for failure to make required disclosure on license application; and,

WHEREAS, Respondent failed to notify the Indiana Department of Insurance of the revocation within thirty (30) days; and,

WHEREAS, Indiana Code 27-1-15.6-12(9) states that the Commissioner may permanently revoke an insurance producer's license for having an insurance producer's license denied, suspended, or revoked in another state; and,

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.


IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives the right to a public hearing on this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Respondent's license shall be permanently revoked, effective the day the Commissioner adopts this Agreed Entry via Final Order.

6. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
7. Respondent has carefully read this agreement and fully understands and accepts its terms.




