FINAL ORDER


The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Joshua Harrison, and Jillian Wood (“Respondent”), an Indiana Non-Resident Producer, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance (the “Commissioner”) for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent shall pay a civil penalty of Seven Hundred and Fifty Dollars and 00/100 (\$750.00), for failing to disclose her 2006 criminal conviction of misdemeanor larceny in North Carolina and failing to disclose administrative actions in the states of Washington and Maine, within thirty (30) days of this Order.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Joshua Harrison, and Jillian Wood ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, on March 22, 2013, Respondent submitted an application for a Non-Resident Producer's license; and,

WHEREAS, on March 26, 2013, Respondent was granted a non-resident producer's license under number 871734; and,

WHEREAS, subsequent to the granting of her license, Respondent uploaded various documents onto the NIPR national warehouse; and

WHEREAS, the information listed on the NIPR national warehouse included documentation of a 2006 criminal conviction of misdemeanor larceny in North Carolina, a

March 2014 administrative action in the state of Washington, and a May 2014 administrative action in the state of Maine; and,

WHEREAS, Indiana Code §27-1-15.6-12(b)(1) states that producers are prohibited from providing incorrect, misleading, incomplete, or materially untrue information in a license application; and,

WHEREAS, on Respondent's 2013 application, she failed to disclose her 2006 criminal conviction of misdemeanor larceny in North Carolina; and,

WHEREAS, Indiana Code §27-1-15.6-17(a) states that producers shall report to the Commissioner any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana not more than thirty (30) days after the final disposition of the matter. The report shall include a copy of the order, consent to order, or other relevant legal documents; and,

WHEREAS, Respondent failed to disclose the March 2014 administrative action in the state of Washington within thirty (30) days; and,

WHEREAS, Respondent failed to disclose the May 2014 administrative action in the state of Maine within thirty (30) days; and,

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.


IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.


3. Respondent voluntarily and freely waives the right to a public hearing on this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Respondent shall pay a civil penalty in the amount of Seven Hundred and Fifty dollars and 00/100 (\$750.00) within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
6. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
7. Applicant has carefully read this agreement and fully understands and accepts its terms.

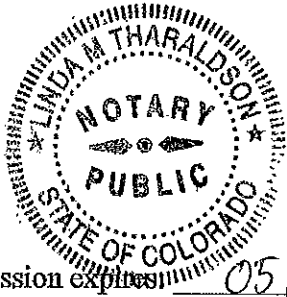
