FINAL ORDER

The Indiana Department of Insurance (“Department”), by counsel, Joshua D. Harrison, and Mark D. Stutsman (“Applicant”), an applicant for an Indiana Nonresident Producer’s license, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance (the “Commissioner”) for approval.


The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Applicant’s Producer’s license shall be granted and placed on probationary status for a period of one (1) year, and applicant shall be ordered to pay an administrative fine of Two Hundred Fifty Dollars and no/100 (\$250.00) for failing to disclose another state’s actions.

2. The administrative fine shall be stayed during the probationary period. If no further violations arise during the said probationary period, the fine amount shall be vacated.

WHEREAS, the Applicant's conduct is a violation of Indiana Code § 27-1-15.6-12(b)(1), which states that an applicant shall not provide incorrect, misleading, incomplete, or materially untrue information in a license application; and,


WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Applicant voluntarily and freely waives the right to a public hearing on this matter.
4. Applicant voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Applicant's Producer's license shall be granted and placed on probationary status for a period of one (1) year, and Applicant shall be ordered to pay an administrative fine in the amount of Two Hundred Fifty Dollars and 00/100 (\$250.00).
6. The administrative fine shall be stayed during the probationary period. If no further violations arise during the said probationary period, the fine amount shall be vacated.


8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
9. Applicant has carefully read this agreement and fully understands and accepts its terms.


