WHEREAS, the Respondent is a licensed resident Insurance Producer, holding license number 932386;

WHEREAS, on January 12, 2014 the Respondent's employment was terminated from State Farm Insurance Company for unlawfully taking one thousand one hundred ninety two dollars and eight cents (\$1,192.08) in premium payments from policyholders;

WHEREAS, the Department acknowledges that full restitution of premium payments have been made;

WHEREAS, the Respondent's actions are in violation of Indiana Code § 27-19-4-5(b)(4), which states that a producer shall not improperly withhold, misappropriate, or convert any monies or properties received in the course of doing business;

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on the issues in this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent agrees to the Permanent Revocation of her Resident Producer License.
- 6. Should additional violations manifest, further administrative actions will be taken for the new violation.
- 7. The Department agrees to accept Respondent's compliance with this agreement as full satisfaction of this matter.
- Respondent has carefully read and examined this agreement and fully understands and accepts its terms.
- 9. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.

- 6. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 7. Respondent is aware that failure to comply with any terms of this agreement will result in the matter being set for a hearing.
