WHEREAS, on September 19, 2013, Respondent submitted an application for a Non-Resident Producer's license; and,

WHEREAS, on September 23, 2013, Respondent was granted a non-resident producer's license under number 905511; and,

WHEREAS, subsequent to the granting of his license, Respondent uploaded various documents onto the NIPR national warehouse; and

WHEREAS, the information listed on the NIPR National Warehouse included documentation of a 2007 criminal conviction for the Unlawful use of Drug Paraphernalia in Missouri; and,

WHEREAS, Indiana Code §27-1-15.6-12(b)(1) states that producers are prohibited from providing incorrect, misleading, incomplete, or materially untrue information in a license application; and,

WHEREAS, on Respondent's 2013 application, he failed to disclose his 2007 misdemeanor conviction for Unlawful Use of Paraphernalia in Missouri; and,

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

## IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this
   Agreed Entry.

- 5. Respondent shall pay a civil penalty in the amount of Two Hundred and Fifty dollars and 00/100 (\$250.00) within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
- 6. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
