- 3. Indiana Code 27-1-15.6-12(g) states that Respondent has ten (10) days to respond to the Department's request for a list of appointments.
- 4. On February 9, 2015, the certified mail receipt for article # 9214 8901 0661 5400 0049 4190 81, was returned by the United States Postal Service ("USPS") marked as delivered and signed by Respondent, indicating receipt of the Commissioner's request.

Respondent failed to provide the requested list of appointments within the ten (10)
days as required by statute.

6. Pursuant to Indiana Code 27-1-15.6-12(h), on March 6, 2015, the Commissioner of the Indiana Department of Insurance (the "Commissioner") issued a Findings of Fact and Suspension Order suspending Respondent's license numbers 929899 and 930659 until such a time as the Respondent supplied the Department with the requested list of appointments.

7. On March 26, 2015, Respondent sent a fax to the Department providing the required list of appointments under Indiana Code § 27-1-15.6-12(g).

WHEREFORE, the Department requests that the Commissioner issue an order lifting the suspension of Respondent's licenses and all other relief just and proper upon the premise.

## FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Terra Administrators, Inc. ("Respondent") is a nonresident insurance producer under license # 929899 and Non-Resident Surplus Lines under license # 930659.

WHEREAS, Indiana Code 27-1-15.6-12(g) states that a licensed producer must furnish the commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding within ten (10) days of a request.

WHEREAS, on February 2, 2015, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a certified letter requesting a list of appointments.

WHEREAS, on February 9, 2015, the certified mail receipt for article # 9214 8901 0661 5400 0049 4190 81, was returned by the United States Postal Service ("USPS") marked as delivered and signed by Respondent, indicating receipt of the Commissioner's request.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as requested by the Commissioner.

WHEREAS, Respondent's failure to provide said list within ten (10) days constitutes a violation of Indiana Code 27-1-15.6-12(g).

WHEREAS, Indiana Code 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, issue an order to suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days.

WHEREAS, pursuant to Indiana Code 4-21.5-4-4, the Commissioner shall set this matter for hearing on this Order upon a request by Respondent.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license numbers 929899 and 930659 are hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments and response requested by the Commissioner.
