ADMINISTRATIVE ORDER
NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance, pursuant to Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Bradley N. Thomas (“Respondent”) and Thomas & Associates, Inc., (“Agency”) of the following Administrative Order:

1. Respondent, a resident of Arkansas, is a licensed insurance producer, holding license number 507419 since October of 2006 (“Respondent’s license”).
2. Respondent’s license will expire on August 31, 2015.
3. Agency, a resident of Arkansas, is a licensed insurance producer organization, holding license number 723023 since December of 2014 (“Agency’s license”).
4. Agency’s license will expire on October 31, 2016.
5. On or about March 05, 2015 the Enforcement Division was notified that Respondent’s resident license was suspended by the Arkansas Insurance Department on January

28, 2015 for his failure to appear at an investigative conference following multiple consumer complaints.

6. On or about March 05, 2015 the Enforcement Division was notified that Agency's resident license was revoked by the Arkansas Insurance Department on January 28, 2015 for the failure of an Agency officer to appear at an investigative conference following multiple consumer complaints.


7. Pursuant to Indiana Code § 27-1-15.6-12(b)(9), the Commissioner may refuse to issue or renew an insurance producer's license if the producer has had a producer's license, or its equivalent, denied, suspended, or revoked in any other jurisdiction.

8. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.

9. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent and Agency may, within sixty three (63) days of receiving this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent and Agency's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent and Agency that **the licenses shall not be renewed.**
