FINAL ORDER

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent shall pay an administrative penalty in the amount of thirteen thousand five hundred dollars (\$13,500.00) to the Department, for agency operating while its license had expired. This amount is due in full within sixty (60) days after the Commissioner signs this Final Order

2. Respondent shall develop, provide, and implement policies to ensure all employees and any agency that requires an insurance license is in compliance with Indiana insurance laws. Respondent shall implement these policies and provide the Department a copy of these policies within thirty (30) days after the Commissioner signs this Final Order.

This Agreed Entry is entered into by Brigitte Collier, attorney for the Title Division of the Indiana Department of Insurance ("Department"), and Marshall County Title & Guaranty Co. Inc. ("Respondent"), a licensed resident title insurance producer, to resolve all issues in the above captioned matter. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, Respondent is a resident title insurance producer holding license number 1436000 since 1987;

WHEREAS, Respondent's license lapsed when Respondent did not pay the renewal fee on or before the license expiration date of January 31, 2014;

WHEREAS, on January 14, 2015, the Respondent renewed and license was effective;

WHEREAS, Indiana Code § 27-1-15.6-13 (b) states Respondent shall not accept a commission, service fee, brokerage fee, or other valuable consideration for selling, soliciting, or negotiating insurance in Indiana if that person is required to be licensed;

WHEREAS, during the lapse of Respondent's license, Respondent was paid for selling, soliciting, or negotiating insurance policies in Indiana in violation of Indiana Code 27-1-15.6-13 (a & b); and

WHEREAS, the Department and Respondent conflectively, the "Parties") desire to resolve their differences and settle their issues without the necessity of a hearing;

IT IS, THEREFORE, NOW AGREED by and between the patties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives her right to a public hearing on the issues in this action.
- 4. Respondent voluntarily and freely waives her right to petition for judicial review of this agreement and the Commissioner's Final Order.
- 5. Respondent agrees to pay an administrative penalty in the amount of thirteen thousand five hundred dollars (\$13,500.00) to the Department within sixty (60) days after the Commissioner signs the Final Order adopting this Agreed Entry.
- Respondent has carefully read and examined this agreement and fully understands its terms.

7. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.

 The Department agrees to accept Respondent's compliance with the agreement as full satisfaction of this matter.

9. Respondent is aware that failure to pay the civil penalty will result in the matter being set for a hearing and may result in the permanent revocation of her insurance license and/or an additional civil penalty.

10. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

11. Further should this Agreed Entry not be accepted by the Commissioner, it is agreed that nothing in this Agreed Entry is to be considered an Admission by Respondent, or the Division, and Respondent and Division shall not be unfairly or illegally prejudiced from participating in the administrative process for resolution of this matter.
