Collier, and Courtney Faulkner ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of the Department's Commissioner, Stephen W. Robertson ("Commissioner");

WHEREAS, the Respondent is a licensed Nonresident Independent Adjuster, holding license number 828667;

WHEREAS, on February 07, 2013, Respondent was denied a license by the Georgia Department of Insurance;

WHEREAS, on April 01, 2015 Respondent was issued a monetary penalty by the Oklahoma Insurance Department;

WHEREAS, Respondent failed to report the administrative actions in a timely manner;

WHEREAS, Respondent's actions are in violation of Indiana Codes §§ 27-1-28-22(a)(1) -(2) state that an independent adjuster shall report to the commissioner an administrative action taken against the independent adjuster in another jurisdiction or by another governmental agency in Indiana not more than thirty (30) days after the final disposition of the matter;

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

## IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on the issues in this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent shall pay an administrative fine of Five Hundred Dollars (\$500.00) within ninety (90) days after the Commissioner signs the Final Order adopting this Agreed Entry.
- 6. Should additional violations manifest, further administrative actions will be taken for the new violation.
- 7. The Department agrees to accept Respondent's compliance with this agreement as full satisfaction of this matter.

- Respondent has carefully read and examined this agreement and fully understands 8. and accepts its terms.
- Respondent has entered into this agreement freely, and has not been subject to 9. duress, threat or undue influence.
- Should this Agreed Entry not be accepted by the Commissioner, it is agreed that 10. presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- Respondent is aware that failure to comply with any terms of this agreement will 11. result in the matter being set for a hearing.
