
IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent’s Nonresident Producer license shall be granted and placed on probationary status for a period of two (2) years, for having been issued a Consent Order by the Ohio

Department of Insurance, and for having a license revoked by the Michigan Department of Financial Services.

2. The Department agrees to accept this agreement as full resolution of this matter.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Brigitte R. Collier, and Giles Gibson (“Applicant”), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, on June 24, 2015, Applicant submitted an application for a Nonresident Producer’s license;

WHEREAS, on said license application, Applicant disclosed a 2011 Consent Order issued by the Ohio Department of Insurance;

WHEREAS, on said license application, applicant disclosed a 2011 license revocation by the Michigan Department of Insurance and Financial Services;

WHEREAS, the Applicant's conduct is a violation of Indiana Code § 27-1-15.6-12(b)(8), which states that an applicant shall not use fraudulent, coercive, or dishonest practices, or demonstrate incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere;

WHEREAS, the Applicant's conduct is a violation of Indiana Code § 27-1-15.6-12(b)(9), which states that an applicant shall not have had an insurance producer's license or its equivalent, denied, suspended, or revoked in any other state, province, district or territory;


WHEREAS, the Department and Applicant (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Applicant voluntarily and freely waives the right to a public hearing on the issues in this matter.
4. Applicant voluntarily and freely waives the right to judicial review of this matter.
5. Applicant's license is granted and shall be placed on a probationary status for a period of two (2) years.
6. Should additional violations manifest, this action shall be in addition to any administrative actions for the new violation.

7. The Department agrees to accept Applicant's compliance with this agreement as full satisfaction of this matter.
8. Applicant has carefully read and examined this agreement and fully understands its terms.
9. Applicant has entered into this agreement freely, and has not been subject to duress, threat or undue influence.
10. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
11. Applicant is aware that failure to comply with any of the terms of this agreement will result in the matter being set for a hearing.
