ADMINISTRATIVE ORDER
NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance, pursuant to Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Casselyn Haynie, (“Respondent”) of the following Administrative Order:

1. Respondent, a nonresident of Indiana, is a licensed insurance producer, holding license number 828012 since July of 2012 (“Respondent’s license”).
2. Respondent’s license expired on September 30, 2014.
3. April 07, 2015, the Enforcement Division was notified that on April 05, 1990 Respondent was found guilty of the military offence wrongful use of cocaine, which was not disclosed in her application for licensure.
4. Additionally, it was discovered that Respondent had been subject a license denial by the Wyoming Department of Insurance on March 20, 2015.
5. Pursuant to Indiana Code § 27-1-15.6-12(b)(1) the commissioner may refuse to renew a producer’s license providing incorrect, misleading, incomplete, or materially untrue information in a license application.

6. Pursuant to Indiana Code §27-1-15.6-12(b)(9) the commissioner may refuse to renew a producer's license for having an insurance producer's license or its equivalent, denied, suspended, or revoked in any other state, province, district or territory.

7. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.

8. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **their license shall not be renewed.**
