**FINAL ORDER**


The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Brigitte R. Collier, and Robert Husnick (“Respondent”), a licensed nonresident insurance producer, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance (the “Commissioner”) for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent shall pay an administrative fine of seven hundred fifty dollars (\$750.00) within thirty (30) days after the Commissioner signs the Final Order, for his failure to disclose three (3) misdemeanors on his application for licensure, and for his failure to timely report an April 04, 2012, Consent Order issued by the Minnesota Department of Commerce, and an October 13, 2012 monetary penalty issued by the Virginia Bureau of Insurance.
2. The Department agrees to accept this agreement as full resolution of this matter.

**AGREED ENTRY**

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Brigitte R. Collier, and Robert Husnick ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of the Department's Commissioner, Stephen W. Robertson ("Commissioner");

WHEREAS, Respondent is a licensed Nonresident Insurance Producer, holding license number 800797;

WHEREAS, Respondent submitted an application for a Nonresident Producer license on January 24, 2012;

WHEREAS, On that application, Respondent failed to disclose three (3) Minnesota misdemeanors;

WHEREAS, Respondent failed to timely report the issuance of an April 04, 2012 Consent Order by the Minnesota Department of Commerce;

WHEREAS, Respondent failed to timely report the October 23, 2012 issuance of a monetary penalty from the Virginia Bureau of Insurance;

WHEREAS, Respondent's actions are in violation of Indiana Code § 27-1-15.6-12(b)(1) which states that a producer shall not provide incorrect, misleading, incomplete, or materially untrue information in a license application.

WHEREAS, Respondent's actions are in violation of Indiana Code §27-1-15.6-17(a), which states that a producer shall report to the commissioner any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana not more than thirty (30) days after the final disposition of the matter;

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.


IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives the right to a public hearing on the issues in this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this matter.
5. Respondent shall pay an administrative fine of Seven Hundred Fifty Dollars (\$750.00) within thirty (30) days after the Commissioner signs the Final Order adopting this Agreed Entry.



6. Should additional violations manifest, further administrative actions will be taken for the new violation.
7. The Department agrees to accept Respondent's compliance with this agreement as full satisfaction of this matter.
8. Respondent has carefully read and examined this agreement and fully understands and accepts its terms.
9. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.
10. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
11. Respondent is aware that failure to comply with any terms of this agreement will result in the matter being set for a hearing.

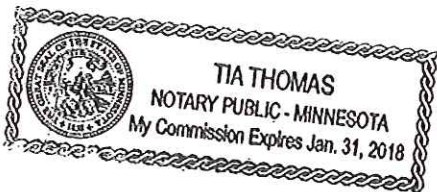
