### FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Elaine J. Hall ("Respondent") is a resident insurance producer under license # 1033955.

WHEREAS, Indiana Code 27-1-15.6-12(g) states that a licensed producer must furnish the commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding within ten (10) days of a request.

WHEREAS, on September 24, 2015, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a certified letter requesting a list of appointments.

WHEREAS, on September 28, 2015, certified mail article # 91 7190 0005 2720 0049 4662 was marked as delivered by the United States Postal Service ("USPS").

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as required under Indiana Code 27-1-15.6-12(g).

WHEREAS, Indiana Code 27-1-15.6-12(h) provides that the commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 1033955 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.

# ORDER GRANTING FOR EMERGENCY SUSPENSION

The Indiana Commissioner of Insurance, having reviewed the Enforcement Division's Motion For Emergency Suspension, and being otherwise duly advised, now finds as follows:

### **Findings of Fact**

- 1. The Department of Insurance is authorized to regulate the practice of insurance agents in Indiana under Indiana Code § 27-1-15.6, which was effective at all times relevant to these charges.
- 2. The Department may hold disciplinary hearing under Indiana Code § 27-1-15.6.
- 3. Elaine J. Hall currently holds a resident producer's license number 103395. Her license expires on January 31, 2018.
  - 4. On April 30, 2015, Respondent submitted an application for licensure.

5. With that application, Respondent submitted a fraudulent Indiana life, accident & health producer license exam score report.

#### Conclusions of Law

- 1. An emergency exists in that Elaine J. Hall continuous selling of insurance in the state of Indiana with a valid license places her in a position of trust with Indiana consumers and their funds could prove to be detrimental.
- 2. Indiana Code § 27-1-15.6-12(b)(3) permits that the commissioner may suspend an insurance producer's license for obtaining a license through fraud.
- 3. In an emergency, the Commissioner may issue appropriate orders without notice or an evidentiary proceeding under Indiana Code § 4-21.5-4-2(a) which states in relevant part:

The agency shall issue the order under this chapter by one (1) of the following procedures:

(1) Without notice or an evidentiary proceeding, by any authorized individual or panel of individuals.

#### <u>Order</u>

It is, therefore, **ORDERED**, that the Indiana insurance license of Elaine J. Hall is hereby **SUSPENDED** pursuant to Indiana Code § 4-21.5-4-2 for 90 days commencing on the date this order is issued.

The Respondent is hereby notified of his right to a hearing concerning this order as quickly as practicable under Indiana Code § 4-21.5-4-4.
