FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Daryl Keesler (“Respondent”) is a nonresident insurance producer under license # 1032986.

WHEREAS, Indiana Code 27-1-15.6-12(g) states that a licensed producer must furnish the commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding within ten (10) days of a request.

WHEREAS, on August 03, 2015, the Commissioner of the Indiana Department of Insurance (“Commissioner”) sent a request for a list of appointments to Respondent via email to the email address daryl.keesler@thehartford.com, which is on record for Respondent.

WHEREAS, the August 03, 2015 email included a request for a “delivery receipt”. A delivery receipt was received by the Department that same day, indicating that the email to Respondent was delivered successfully.

WHEREAS, on August 31, 2015, the Commissioner resent the request for a list of appointments to Respondent by certified mail.

WHEREAS, on September 30, 2015, certified mail article # 91 7190 0005 2720 0048 3192 was returned by the United States Postal Service ("USPS") marked as return to sender because it was unclaimed.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as required under Indiana Code 27-1-15.6-12(g).

WHEREAS, Indiana Code 27-1-15.6-12(h) provides that the commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 1032986 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
