- 6. Provided no other issues arise, once said administrative fine is paid, Applicant's application for licensure shall be granted.
- 7. The Department agrees to accept Applicant's compliance with this agreement as full satisfaction of this matter.
- 8. Applicant has carefully read and examined this agreement and fully understand its terms.
