WHEREAS, the Respondent's actions are in violation of Indiana Code §27-1-15.6-17(a), which states that a producer shall report to the commissioner any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana not more than thirty (30) days after the final disposition of the matter;

WHEREAS, James B. Johnston, President and Owner of James B Johnston Inc, is authorized to act on behalf of Respondent and obligate it to perform in accordance with this agreement;

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

- 6. Should additional violations manifest, further administrative actions will be taken for the new violation.
- The Department agrees to accept Respondent's compliance with this agreement as full satisfaction of this matter.
- 8. Respondent has carefully read and examined this agreement and fully understands and accepts its terms.

- 9. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.
- 10. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 11. Respondent is aware that failure to comply with any terms of this agreement will result in the matter being set for a hearing.
