MOTION TO LIFT SUSPENSION ORDER


The Indiana Department of Insurance Enforcement Division ("Department"), by counsel Joshua D. Harrison, now moves that the Suspension Order of October 02, 2015 be lifted. In support of this request the Department asserts the following:

1. Stephanie Owen ("Respondent") is an individual nonresident insurance producer under license #974288.
2. On August 13, 2015, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a certified letter requesting a list of appointments.
3. On September 15, 2015, certified mail article # 91 7190 0005 2720 0047 6576 was returned by the United States Postal Service ("USPS") marked as unclaimed.
4. On September 15, 2015, the Commissioner resent the August 13, 2015 request for a list of appointments to Respondent via the email address on record with the Department that was provided by Respondent.

5. The September 15, 2015 email included a request for a "delivery receipt". A delivery receipt was received by the Department that same day, indicating that the email to respondent was delivered successfully.
6. More than ten (10) days elapsed since the Commissioner requested a list of appointments.
7. Pursuant to Indiana Code §27-1-15.6-12(g) on October 02, 2015, the Commissioner issued a Suspension Order suspending Respondent's license number 974288 until such a time as the Commissioner received Respondent's list of appointments.
8. On January 04, 2016, Respondent sent an email to the Department providing a list of appointments.

WHEREFORE, the Department requests that the Commissioner issue an order lifting the suspension of Respondent's licenses and all other relief just and proper upon the premise.



FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Stephanie Owen ("Respondent") is a nonresident insurance producer under license # 974288.

WHEREAS, Indiana Code 27-1-15.6-12(g) states that a licensed producer must furnish the commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding within ten (10) days of a request.

WHEREAS, on August 13, 2015, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a certified letter requesting a list of appointments.

WHEREAS, on September 15, 2015, certified mail article # 91 7190 0005 2720 0047 6576 was returned by the United States Postal Service ("USPS") marked as unclaimed.

WHEREAS, on September 15, 2015, the Commissioner resent the August 13, 2015 request for a list of appointments to Respondent via email to the email address stephanie.owen@mercier.com, which is on record for Respondent.


WHEREAS, the September 15, 2015 email included a request for a "delivery receipt". A delivery receipt was received by the Department that same day, indicating that the emails to Respondent were delivered successfully.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as required under Indiana Code 27-1-15.6-12(g).

WHEREAS, Indiana Code 27-1-15.6-12(h) provides that the commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 974288 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
