FINDINGS OF FACT AND ORDER REVOKING BAIL AGENT LICENSE

Indiana Bail Agent License No. 749068

The Commissioner of the Indiana Department of Insurance ("Commissioner"), having reviewed the Enforcement Division's Motion to Revoke Bail Agent License, now enters the following Findings of Fact and Order Revoking Bail Agent License.

FINDINGS OF FACT

- 1. Geoffrey Lyle Fulton ("Respondent") is a licensed bail agent, holding license number 749068.
- On January 28, 2016, Starke County Circuit Court entered a Judgment of Conviction against Respondent on the count of Resisting Law Enforcement, a Level 6
 Felony.
- 3. Ind. Code §27-10-3-8(d) states: "The Commissioner shall revoke the license of any person who is convicted of a disqualifying offense immediately upon conviction. The pending of sentencing or the pending of an appeal of a conviction of a disqualifying offense does not stay the revocation of a license under this subsection."

4. Ind. Code §27-10-1-6 defines a disqualifying offense as either a felony or

a misdemeanor if an element of the offense involves dishonesty, violence, or a deadly

weapon.

5. Respondent's conviction was entered as a Level 6 Resisting Law

Enforcement, which is a felony with an element of violence.

6. Ind. Code §27-10-3-8(d) further states: "A person convicted of a felony is

not eligible to reapply for a license until ten (10) years from the date of conviction or

release from imprisonment, parole, or probation, whichever is later."

ORDER REVOKING BAIL AGENT LICENSE

The Commissioner, having reviewed the Enforcement Division's Motion to

Revoke Bail Agent License, now GRANTS said motion. Therefore, Respondent's bail

agent license, number 749068, is hereby immediately revoked. Respondent may not

reapply for a license until ten (10) years from the date of conviction or release from

imprisonment, parole, or probation, whichever is later.

The pending of sentencing or the pending of an appeal of a conviction of a disqualifying offense does not stay the revocation of a license under this subsection."
- 4. Ind. Code §27-10-3-8(d) further states: "A person convicted of a felony is not eligible to reapply for a license until ten (10) years from the date of conviction or release from imprisonment, parole, or probation, whichever is later."

WHEREFORE, the Division, by its counsel Joshua D. Harrison, respectfully requests that the Commissioner issue an order revoking Respondent's bail agent license per the terms of Ind. Code §27-10-3-8(d).
