AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel Brigitte Collier, and John Douglas Busch ("Respondent") to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance ("Commissioner").

WHEREAS, on October 27, 2014, Respondent applied for and obtained an Indiana Resident Producer's License under number 994210;

WHEREAS, on Respondent's application, he failed to disclose a June 1, 2011 administrative action in which the Board of Chiropractic Examiners in Colorado placed Respondent's Colorado Chiropractor license on probation due to billing and record keeping practices that fell below the generally accepted standards;

WHEREAS, on Respondent's application, he failed to disclose a June 20, 2013 administrative action in which the Board of Chiropractic Examiners of Indiana placed Respondent's Indiana Chiropractor license on indefinite probation due to the disciplinary proceeding against his Colorado license;

WHEREAS, on Respondent's application, he failed to disclose a July 18, 2012 administrative action in which the Medical Licensing Board of Indiana placed Respondent's Indiana Acupuncturist license on indefinite probation due to the disciplinary proceeding against his Colorado license;

WHEREAS, Indiana Code § 27-1-15.6-12(b)(1) states, in part, that the Commissioner may levy a civil penalty against a producer for providing incorrect, misleading, incomplete, or materially untrue information in a license application; and

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on the issues in this matter.
- Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent shall pay an administrative fine in the amount of seven hundred fifty dollars (\$750.00) within thirty (30) days after the Commissioner signs the Final Order adopting this Agreed Entry.

- 6. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- Respondent is aware that failure to comply with any of the terms of this agreement will 8. result in the matter being set for a hearing.
