FINAL ORDER


The Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel Brigitte R. Collier, and Kendra Aleman ("Respondent"), an application for a non-resident insurance producer, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance (the "Commissioner") for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner as follows:

1. Respondent shall pay an administrative fine of two hundred fifty dollars (\$250.00) within thirty (30) days after the Commissioner signs the Final Order, for her failure to disclose an administrative action taken by the state of California for misrepresentation of coverage on an insurance certificate.
2. The Department agrees to accept this agreement as full resolution of this matter.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel Brigitte Collier, and Kendra Aleman ("Applicant"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance ("Commissioner").

WHEREAS, on or around January 22, 2016, Applicant submitted an application for a Non-Resident Producer's license;

WHEREAS, Indiana Code § 27-1-15.6-12(b)(1) authorizes the Commissioner to levy a civil penalty against a producer for providing incorrect, misleading, incomplete, or materially untrue information in a license application;

WHEREAS, on said license application, Applicant failed to disclose an October 10, 2015 administrative action from the state of California Department of Insurance. The action was due to a complaint filed by a policy holder against Applicant for misrepresentation of the coverage on the certificate of insurance; and,

WHEREAS, the Department and Applicant (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.


IT IS, THEREFORE, NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Applicant voluntarily and freely waives the right to a public hearing on this matter.
4. Applicant voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Respondent shall pay an administrative fine in the amount of two hundred fifty dollars (\$250.00) within thirty (30) days after the Commissioner signs the Final Order adopting this Agreed Entry.
6. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

7. Applicant has carefully read this agreement and fully understands and accepts its terms.
