FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Dawn Crowder (“Respondent”) is a non-resident insurance producer under license number 1016922.

WHEREAS, Indiana Code 27-1-15.6-12(g) states that a licensed producer must furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the preceding year within ten (10) days of a request.

WHEREAS, on April 25, 2016, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a certified letter requesting a list of appointments.

WHEREAS, on May 18, 2016, the certified letter with the delivery tracking number 9171900005272000590463 was received and marked as “unclaimed/max hold time” by the United States Postal Service.

WHEREAS, on May 19, 2016, a copy of the original letter was mailed to Respondent regular by the United States Postal Services.

WHEREAS, on May 19, 2016, an email was sent to the email address listed on Respondent's record with the Department . A copy of the original letter mailed on April 25, 2016 was attached to the email.


WHEREAS, on May 19, 2016, an email was received and marked as delivered by the Mail Delivery Subsystem as successful with the delivery notification receipt from Respondent's email address.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as required under Indiana Code 27-1-15.6-12(g).

WHEREAS, Indiana Code 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 627302 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
