## **AGREED ENTRY**

This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance ("Commissioner").

WHEREAS, Respondent is a resident title insurance agency licensed in the State of Indiana, holding license number 539564; and

WHEREAS, the NAIC Guidelines provides that "final polices need to be issued within forty-five (45) days"; and

WHEREAS, Respondent failed to issue three hundred twenty eight (328) final policies within forty five (45) days; and

WHEREAS, Indiana Code § 27-1-15.6-13 (a) requires Respondent to only pay a commission, service fee, brokerage fee, or other valuable consideration to a person for selling, soliciting, or negotiating insurance in Indiana if that person is licensed; and

WHEREAS, Examiner determined that Respondent's agency operating license number had expired; and

WHEREAS, Mark Myers, President/CEO of CU Title Services is authorized to act on behalf of Respondent and obligated to perform in accordance with this agreement; and

WHEREAS, the Department and Respondent desire to resolve their differences and settle their issues without incurring the time and expense of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing in this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent agrees to pay an administrative penalty in the amount of eight thousand four hundred eighty nine dollars (\$8,489.00) to the Department within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
- 6. The Department agrees to accept Respondent's compliance with the agreement herein as full satisfaction of this matter.

- 7. Respondent has carefully read and examined this agreement and fully understands its terms.
- 8. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.
- 9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 10. Respondent is aware that failure to comply with any term of this agreement will result in the matter being set for hearing.
