FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, on April 04, 2016, certified mail article # 91 7190 0005 2720 0056 5867 was returned marked as "unclaimed" by the United States Postal Service ("USPS").

WHEREAS, on April 04, 2016, the Commissioner resent the March 02, 2016 request for a list of appointments to Respondent via email to an email address on record for Respondent.

WHEREAS, the April 04, 2016 email included a request for a "delivery receipt". A delivery receipt was received by the Department that same day, indicating that the email to Respondent was successfully delivered.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as required under Indiana Code 27-1-15.6-12(g).

WHEREAS, Indiana Code 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license # 477137 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
