## PRELIMINARY ADMINISTRATIVE ORDER AND NOTICE OF CERTIFICATION DENIAL

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code §4-21.5-1 *et seq.* and Indiana Code §27-19-4, hereby gives notice to Palivia G. Lewis ("Applicant") of the following Administrative Order:

- Applicant filed an application for certification with the Commissioner of the Indiana
   Department of Insurance ("Commissioner") on March 11, 2016.
- 2. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code §27-19-4-3 and Indiana Code §27-19-4-5.
- 3. Indiana Code §27-19-4-3(a)(8) provides that if a person is a navigator, they must not have been convicted of a felony or other crimes determined by the commissioner.
- 4. Following a review of materials submitted by Applicant in support of her application, the Commissioner being fully advised, now hereby notifies Applicant that she has not fully met the requirements of licensure as stated by Indiana Code §27-19-4-3(a)(8) due to her May 02, 1995 conviction for Theft of Bank Funds, a Felony.

5. Should Applicant wish for the Commissioner to review this decision, Applicant must, within fifteen (15) days after receiving notice of this Order, file a written petition with the Commissioner. This petition must state facts demonstrating that Applicant:

(A) is a person to whom this Order is specifically directed;

(B) is aggrieved or adversely affected by this Order; or

(C) is entitled to review under any law

6. If a petition for review is granted, the Department shall assign the matter to an administrative law judge to conduct informal proceedings to settle the matter.

IT IS THEREFORE ORDERED that the Applicant's request for certification is hereby DENIED due to her felony conviction for theft of bank funds, pursuant to Indiana Code §27-19-4-5.
