WHEREAS, the Respondent's conduct is a violation of Indiana Code § 27-1-15.6-12(b)(1), which states that an applicant shall not provide incorrect, misleading, incomplete, or materially untrue information in a license application;

WHEREAS, the Department and Applicant (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

# IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on the issues in this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent shall pay an administrative fine in the amount of Five Hundred Dollars (\$500.00) within thirty (30) days after the Commissioner signs the Final Order adopting this Agreed Entry.
- 6. The Department agrees to accept Respondent's compliance with this agreement as full satisfaction of this matter.
- 7. Respondent has carefully read and examined this agreement and fully understands its terms.
- 8. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.



- Respondent is aware that failure to comply with any of the terms of this 10. agreement will result in the matter being set for a hearing.


