This amount is due in full within thirty (30) days after the signing of this Final Order.

This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance ("Commissioner").

WHEREAS, Respondent is a resident title insurance agency licensed in the State of Indiana, holding license number 1169010;

WHEREAS, the National Association of Insurance Commissioners guidelines provide that "final polices need to be issued within forty-five (45) days;"

WHEREAS, Respondent failed to issue ten (10) final policies within forty five (45) days;

WHEREAS, Indiana Code § 6-1.1-12-43(e)(1) requires that title producers enter information into the RREAL IN database as soon as possible after the closing;

WHEREAS, the Department has interpreted this to be ten (10) business days;

WHEREAS, the Respondent failed to enter nine (9) real estate transactions into the RREAL IN database within the required time period;

WHEREAS, William H. Bender, President of Allyn Abstract Co. Inc., is authorized to act on behalf of Respondent and obligate it to perform in accordance with this agreement; and

WHEREAS, the Department and Respondent desire to resolve their differences and settle their issues without incurring the time and expense of a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing in this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent agrees to pay an administrative penalty in the amount of one thousand ninety dollars (\$1090) to the Department within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
- 6. The Department agrees to accept Respondent's compliance with the Agreed Entry herein as full satisfaction of this matter.

- 7. Respondent has carefully read and examined this Agreed Entry and fully understands its terms.
- 8. Respondent has entered into this Agreed Entry freely, and has not been subject to duress, threat or undue influence.
- 9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 10. Respondent is aware that failure to comply with any term of this agreement will result in the matter being set for hearing.
